**Figure 1 - 1: Manufacturing Employment Growth Comparison with California and U.S.**

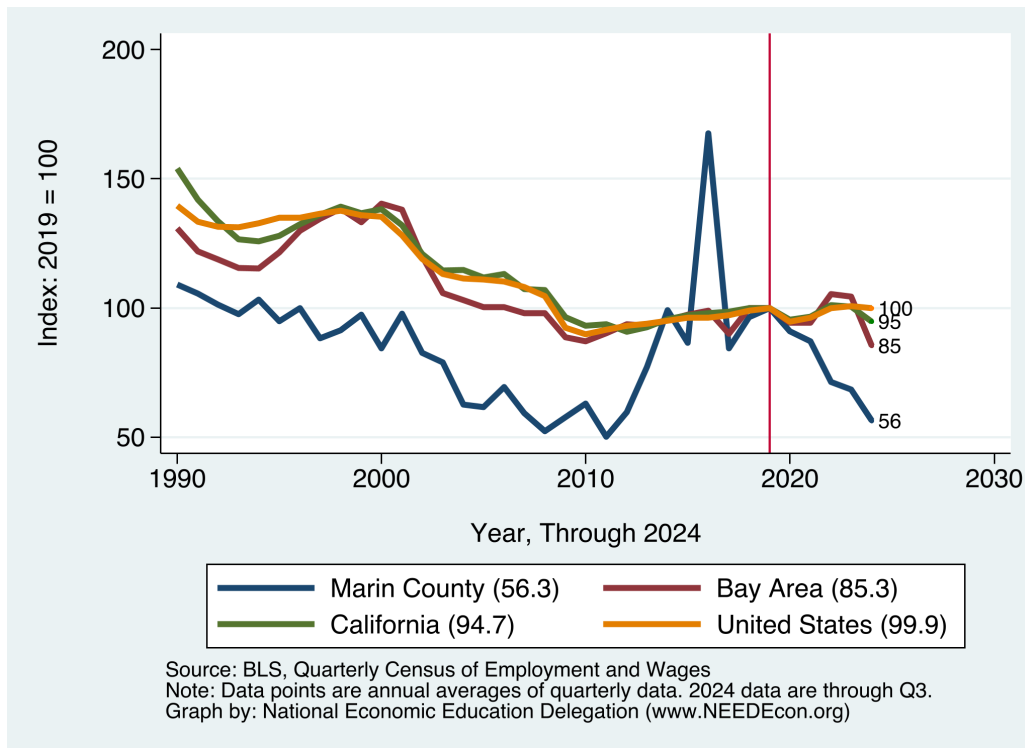


Figure 1 - 2: Employment Growth

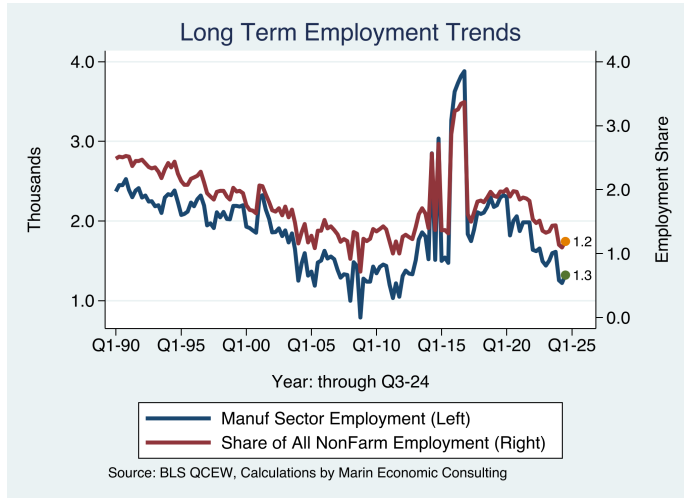
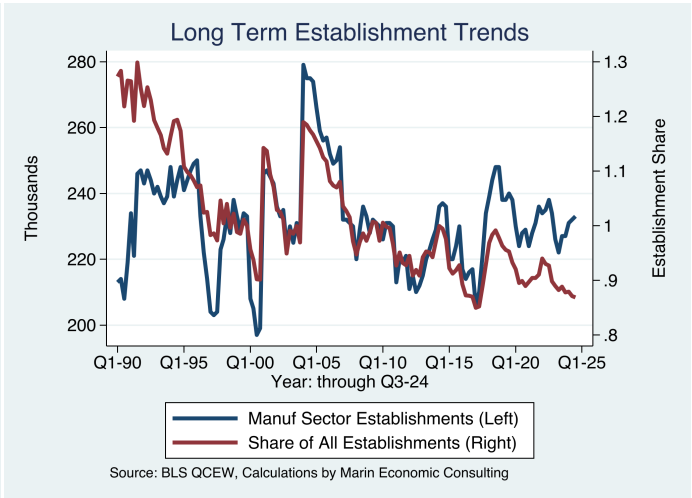
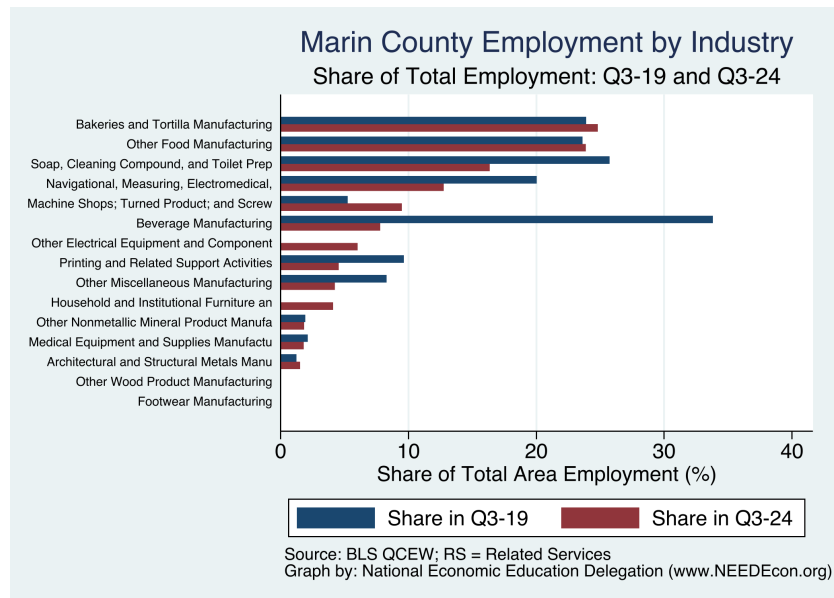


Figure 1 - 3: Establishment Growth

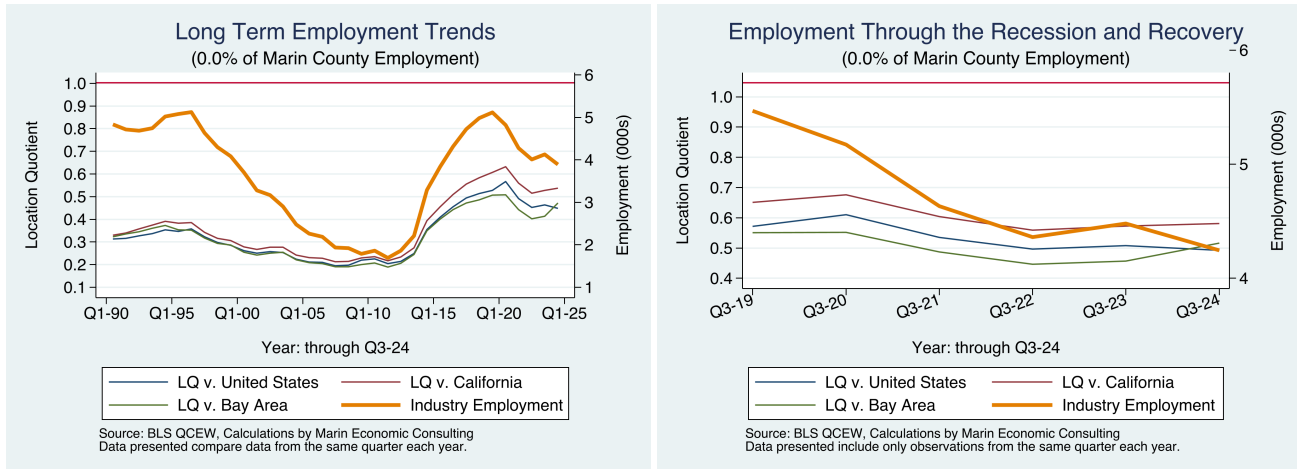


Figure 3 - 2: 325: Chemical Manufacturing

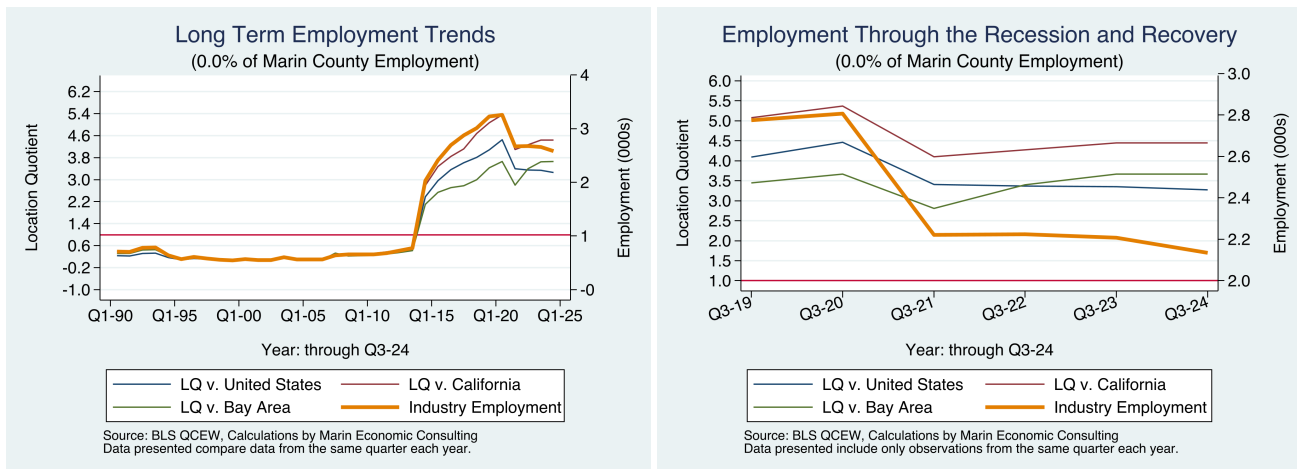


Figure 3 - 3: 311: Food Manufacturing

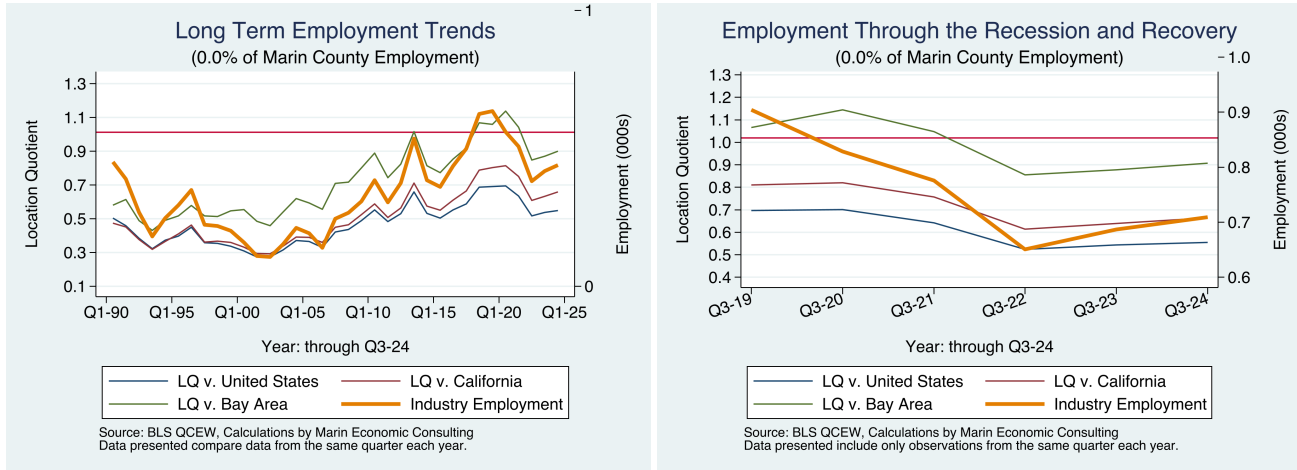


Figure 3 - 4: 334: Computer and Electronic Product Manufacturing

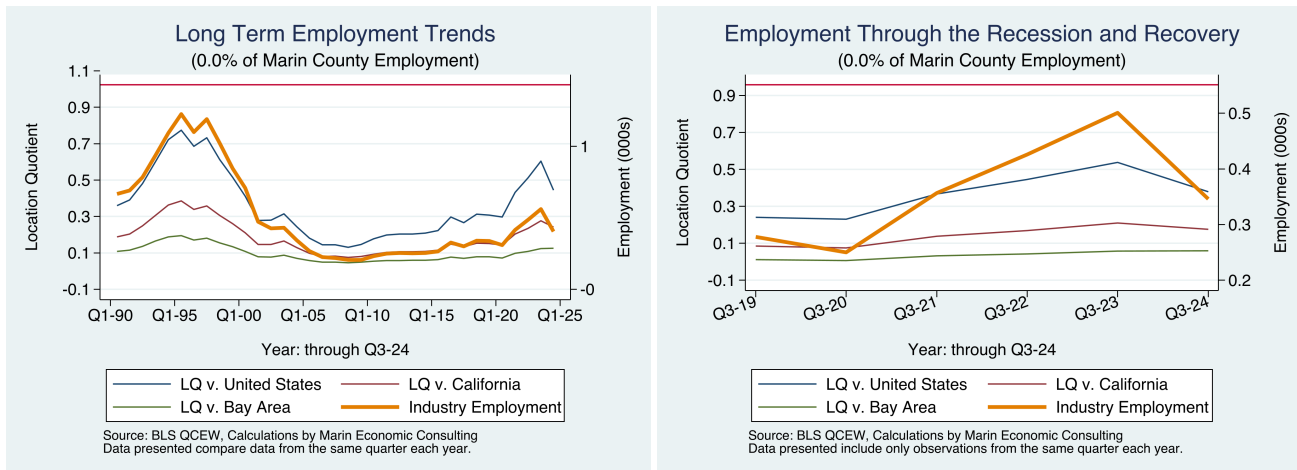


Figure 3 - 5: 3118: Bakeries and Tortilla Manufacturing

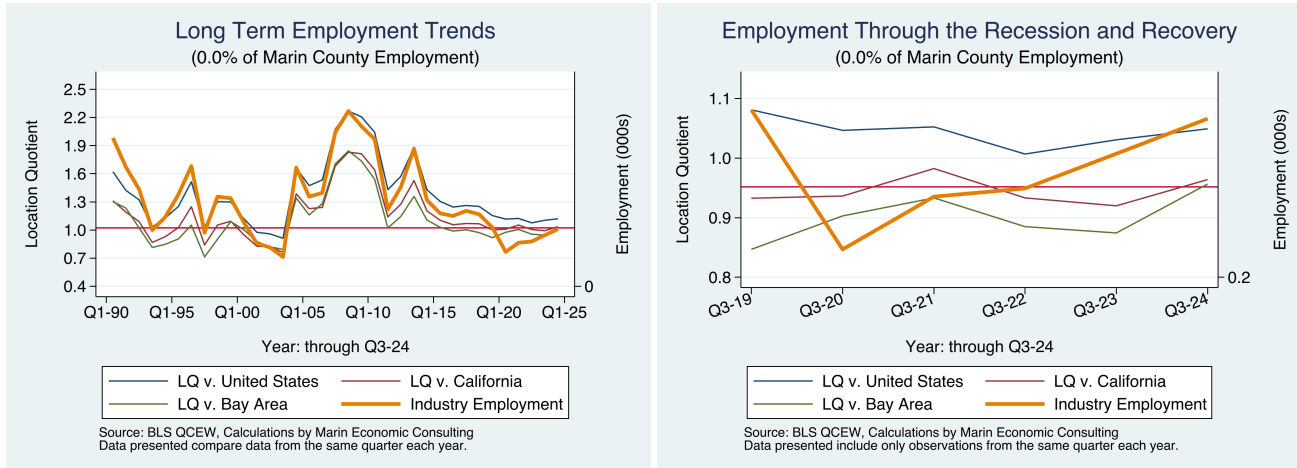


Figure 3 - 6: 3119: Other Food Manufacturing

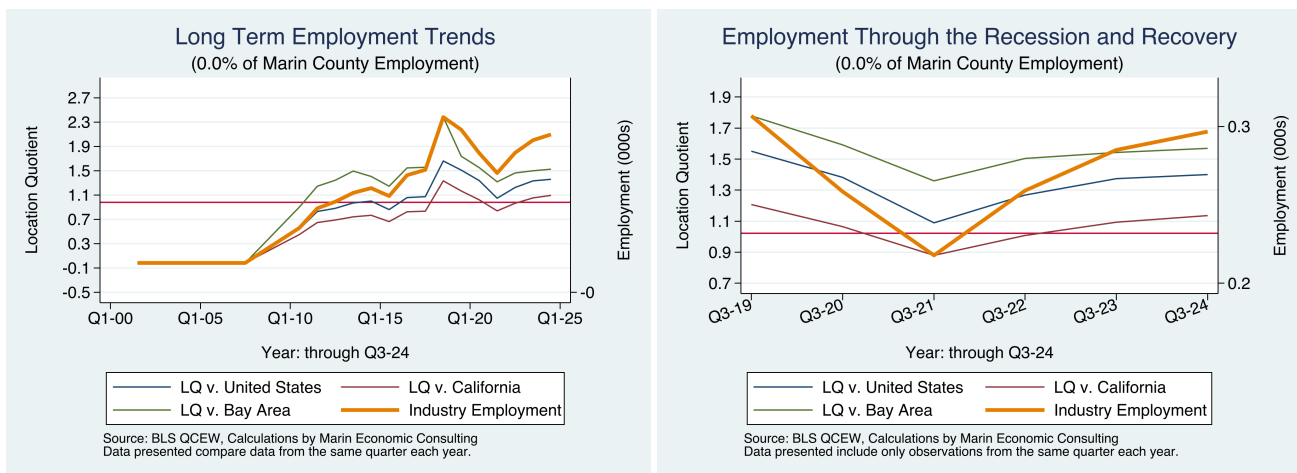


Figure 3 - 7: 327: Nonmetallic Mineral Product Manufacturing

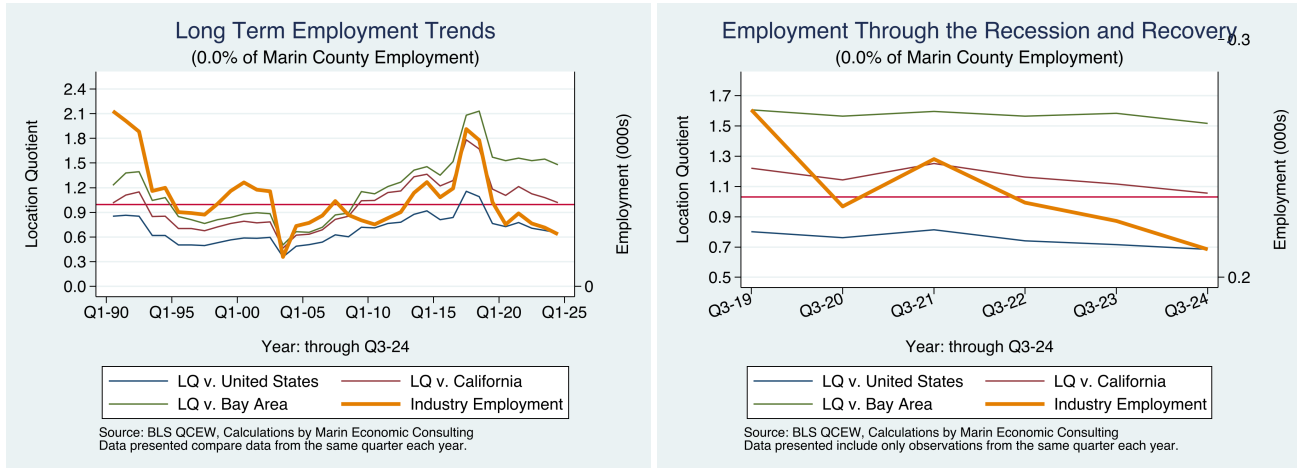


Figure 3 - 8: 3256: Soap, Cleaning Compound, and Toilet Preparation Manufacturing

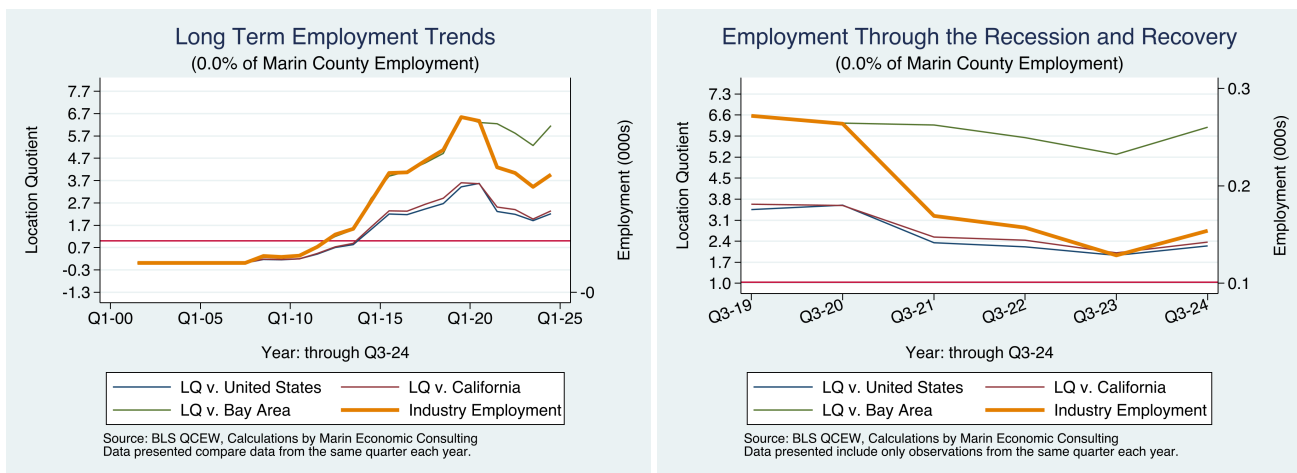


Figure 3 - 9: 332: Fabricated Metal Product Manufacturing

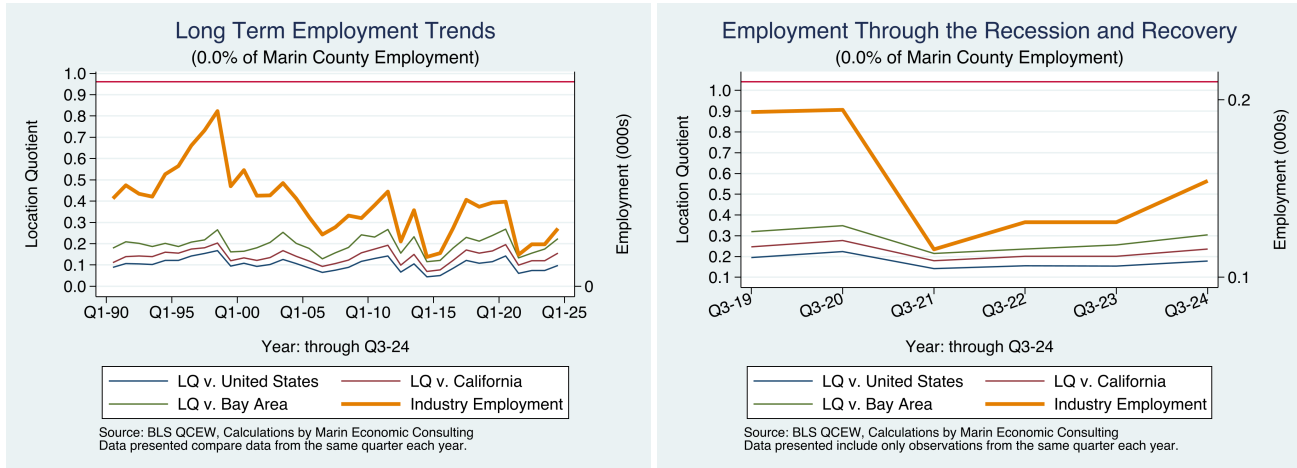


Figure 3 - 10: 3345: Navigational, Measuring, Electromedical, and Control Instruments Manufacturing
